

## Terms and Conditions

# Win a Share of \$30,000 Worth of Groceries at Market Central Lutwyche

### Terms and Conditions

1. Information on how to enter and prizes form part of these terms and conditions. Participation in this promotion is deemed acceptance of these terms and conditions.
2. Entry into the promotion is open to all residents of Australia **excluding** retail tenants of Market Central Lutwyche and their immediate family, and staff of retail tenants in the centre and their immediate family, the proprietors and staff of companies involved in the production, publishing and administration of this promotion and their immediate family. Immediate family means parents, siblings, spouse, children and grandparents. Tenants means Lessees, Licensees and in the case of a corporation, their directors and officers.
3. The Promotion commences 9:00am local Queensland time on Monday 9 March 2020 and ends at 2:00pm local Queensland time on Saturday 2 May 2020 ("Promotional Period"). Entries for each stage of the Promotion close at 1:30pm local Queensland time on the date as detailed on the Entry Form for that relevant stage (for example, entries for Prize 1 close at 1:30pm local Queensland time on 21 March 2020 ("Relevant Promotional Period")).
4. To be eligible to enter, individuals must **spend \$30 or more** in ANY **Specialty Store** at Market Central Lutwyche or **\$100 or more in Coles, Woolworths or ALDI** at Market Central Lutwyche during the Relevant Promotional Period ("Qualifying Purchase"). To enter, individuals must first qualify with the minimum spend, then complete the official entry form available from participating retailers, then place entry in the entry barrel located near ALDI during the Relevant Promotional Period.
5. Every time a customer spends \$30 or more in any Specialty Store at Market Central Lutwyche they are entitled to one entry. Every time a customer spends \$100 or more in Coles, Woolworths or ALDI at Market Central Lutwyche, they are entitled to one entry. This offer applies to instore purchases at Market Central Lutwyche only.
6. No lay-by payments made throughout the campaign will be accepted.
7. Purchase amounts will be rounded up to the nearest dollar value.
8. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of resident) and to disqualify any entrant who submits an entry that is not in accordance with these terms and conditions or who tampers with the entry process. Errors and omissions will be accepted at the Promoters discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
9. Incomplete, indecipherable or illegible entries will be deemed invalid.
10. Multiple entries are permitted, subject to the following: (a) only one (1) entry permitted per specified Qualifying Purchase; and (b) each entry must be submitted separately and in accordance with entry requirements.
11. Entrants must retain their original or a photocopy of their purchase receipt (s) for proof of purchase. Failure to produce the proof of purchase for all entries when requested may, in the absolute discretion of the Promoter, result in invalidation of ALL of the entrant's entries and forfeiture of any rights to a prize.
12. A draw will take place at Market Central Lutwyche four times during the Promotional Period. Prize 1 will be drawn on Saturday 21 March 2020 at 1:30pm. Prize 2 will be drawn on Saturday 4 April 2020 at 1:30pm. Prize 3 will be drawn on Saturday 18 April 2020 at 1:30pm. Prize 4 will be drawn on Saturday 2 May at 1:30pm. If the winners are not present at the draw, they will be notified via phone and in writing within 48 hours. The Promoter's decision is final and no correspondence will be entered into.
13. The total prize pool on offer is broken down as follows:
  - a. **A year's supply of pantry staples from The Source Bulk Foods Lutwyche and Fruit and Vegetables from Farm Fresh – Prize 1**

The prize will be issued on a weekly basis, instore at The Source Bulk Foods Lutwyche and Farm Fresh, for a period of one year (52 weeks). The weekly instalments from The Source Bulk Foods Lutwyche must not exceed \$38.50 in value, total prize value \$2,000. The weekly instalments from Farm Fresh must not exceed \$57.70 in value, total prize value \$3000. The weekly prize instalments can only be redeemed at The Source Bulk Foods Lutwyche and Farm Fresh between the hours of 9:00am and 4:00pm, Monday to Sunday, beginning on a date agreed to by the Winner and the Promoter and are to be redeemed on a weekly basis. The weekly instalment for a week will be

forfeited if not redeemed during that week. The prize must be claimed within 48 hours of notification or will be redrawn.

**b. A year's supply of groceries from ALDI Lutwyche – Prize 2**

The prize will be issued on a weekly basis, instore at ALDI Lutwyche, for a period of one year (52 weeks). The weekly instalments must not exceed \$96.16 in value, total prize value \$5,000. The weekly prize instalments can only be redeemed at ALDI Lutwyche during business hours, Monday to Sunday, beginning on a date agreed to by the Winner and the Promoter and are to be redeemed on a weekly basis. The weekly instalment for a week will be forfeited if not redeemed during that week. The prize cannot be exchanged for cash or any other prize or gift vouchers. The prize cannot be used to purchase special buys products. The prize must be claimed within 48 hours of notification or will be redrawn.

**c. A year's supply of groceries from Coles Lutwyche – Prize 3**

The prize will be issued on a weekly basis, instore at Coles Lutwyche, for a period of one year (52 weeks). The weekly instalments must not exceed \$192.31 in value, total prize value \$10,000. The weekly prize instalments can only be redeemed at Coles Lutwyche between the hours of 9:00am and 4:00pm, Monday to Sunday, beginning on a date agreed to by the Winner and the Promoter and are to be redeemed on a weekly basis. The weekly instalment for a week will be forfeited if not redeemed during that week. The prize cannot be exchanged for cash or any other prize or gift vouchers. The prize cannot be used to purchase tobacco products. The prize cannot be used to purchase merchandise. The prize must be claimed within 48 hours of notification or will be redrawn.

**d. A year's supply of groceries from Woolworths Lutwyche – Prize 4**

The prize will be issued on a weekly basis, instore at Woolworths Lutwyche, for a period of one year (52 weeks). The weekly instalments must not exceed \$192.31 in value, total prize value \$10,000. The weekly prize instalments can only be redeemed at Woolworths Lutwyche during business hours, Monday to Sunday, beginning on a date agreed to by the Winner and the Promoter and are to be redeemed on a weekly basis. The weekly instalment for a week will be forfeited if not redeemed during that week. The prize cannot be exchanged for cash or any other prize or gift vouchers. The prize cannot be used to purchase tobacco products. The prize cannot be used to purchase merchandise. The prize must be claimed within 48 hours of notification or will be redrawn.

14. The total prize pool value is valued at **\$30,000**. Prizes are not transferable or exchangeable and cannot be taken as cash.

If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any entrant; or (b) subject to any written discretions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.

Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including negligence), for any personal injury, or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where arising out of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) use of a prize.

The Promoter collects personal information in order to conduct the Promotion and may, for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required to Australian regulatory authorities. Entry is conditional on providing this information. The Promoter may, for an indefinite period, unless otherwise advised, use the information for promotional, marketing, publicity, research and profiling purposes, including sending electronic messages or telephoning the entrant. Entrants should direct any request to access, update or correct information to the Promoter. All entries become the property of the Promoter.
